In the Mayor's report: the Mayor read a letter from Shane updating the council on the current grants. The sidewalks are on hold until spring, he is searching for a contractor to install sewer pumps, and the well completion form has been sent to the State Engineers Office for the Husky Raw Water. He asked the Council what they wanted to do about the scope on energy grant, it was tabled until the end of the meeting. He is planning on attending the Mayor's meeting in Lovell on January 21st for the consensus grant, he is also taking the following wish list:

1. Match for Water Filtration System
2. Sewer Update
3. Streets
4. Existing Alleys
5. Street Lights

Dalin Winters presented the council with an idea for a Business Park. He has some businesses that are interested in renting office space. He has already been in contact with the Wyoming Business Council and would be willing to write the grant. The Council thinks it would be a good idea and Dalin will get some more information and building plans for the next meeting.

Leonard Broederlow expressed his concern about not being able to hear the council when it is broadcasted on TV. Ryan Olson is going to look into some different options and get back to the council.

Larry gave a presentation on the WAM Video Conference about the 2010 budget.

In the Husky Addition, there was some discussion on the water rights belonging to the roads being reassigned. Larry asked if possible to have Heber Jensen attend the next meeting to explain, Bruce is going to ask him.

Nothing to report on the Roads & Ditches, Water & Sewer and Parks.

Ken Cook reported that he is still waiting on the report for The Old Hotel

Wade made a motion, seconded by Ken Cook to approve Ordinance 10-1--Amending the 2009-2010 Budget on first reading, all were in favor.

There being no further business the meeting adjourned at 8:40 p.m. Ken Cook made a motion to adjourn, seconded by Wade, all were in favor.
