The Town of Burlington held its regular monthly meeting on January 13, 2009 at the Town Hall.

Mayor Kenneth Hockley called the meeting to order at 7:30 p.m.

The minutes of December 9, 2008 were read and reviewed by the Mayor and Council. Doug made a motion to approve the minutes, seconded by Wade, all in favor.

The Town has \$200,321.02 in the General Fund, \$3,692.48 in the Capitol Projects Fund, \$120,467.90 in the Water Fund, and \$13,364.34 in the Sewer Fund.

They Mayor reported that the town was awarded a grant for \$93,745.00, from SLIB, for the streets. He also reported that he is going to the next Town meeting in Manderson to discuss police patrol.

Shane Trotter from Holm, Blough and Company, gave the council an estimate on what it would cost to open all of 5<sup>th</sup> street. He also had the council review that plans for the raw water; it should be ready to bid by the end of the month.

After much discussion the council decided to check with a few people before they make any decisions about opening 5<sup>th</sup> street.

There was nothing new to report in the Husky Addition, Road & Ditches, Water & Sewer and Parks.

The council brief discussed the SLIB grant for the streets; they are looking at the best way to utilize the funds for dust control.

The council reviewed the 2009-2010 budget, Doug made a motion seconded by Ken Cook, to pass it on the 1<sup>st</sup> read, all were in favor.

There being no further business, the meeting adjourned at 8:54 p.m. Doug made a motion to adjourn, seconded by Wade, all in favor. Next meeting will be February 10, 2009, at 7:30 p.m., at the Town Hall.
