

TOWN OF BURLINGTON
July 14, 2009

The Town of Burlington held its regular monthly meeting on July 14, 2009 at the Town Hall.

Officers present: Ken Hockley, Larry Zeitner, Ken Cook, Wade Aagard and Doug Allen. Also present, Bruce Dooley, Melissa Chatwin, Stacy Philippi, Julio Gutierrez, Terry Stanworth, Sean Patrick, Aaron Stanworth, Cortney Allen, Carol Powers, Beatrice Davidson, Stormi Allen, Macey Allen and Mike Reilly.

Mayor Kenneth Hockley called the meeting to order at 7:35 p.m.

The minutes of June 9, 2009 were read and reviewed by the Mayor and Council. Ken Cook made a motion to approve the minutes with one correction in regards to the terminology of Stacey Philippi's questions, seconded by Larry, all were in favor.

The Town has \$201,923.22 in the General Fund \$2,972.48 in the Capitol Projects Fund, \$80,393.84 in the Water Fund, and \$19,935.19 in the Sewer Fund.

Wade made a motion to accept the vouchers as presented, seconded by Doug. Motion passed, all in favor.

The Mayor read a letter from Shane Trotter updating the council on the projects he is working on.

The Mayor had nothing to report in the Mayor's Report.

Beatrice Davidson expressed her concern about the dogs in town, the council is going to look into what they can do.

Carol Powers asked the council if there was anything they could do about the vacant lots to keep the weeds down, so that they don't spread to other lots and keeps the town looking nice.

Mike Reilly representing RMM Holding Company, Inc. asked the council if he could get official decision with details about using the alley for access road to his property.

Doug made a motion to allow RMM Holding Company, Inc. unlimited access to the alley so he can access his property, Ken Cook seconded the motion, all were in favor.

Stacy Philippi asked the council to relook at pay in half of her CAT bill and apply it to her town bill.

Doug made a motion, seconded by Larry to pay 1/2 of the CAT bill by applying a credit to her water bill. Mayor called for a vote, it passed 3 to 1.

Wade made a motion, seconded by Ken Cook to approve Leslie Allen's Building Permit, all were in favor, Doug abstained from voting.

Doug made a motion, seconded by Larry to approve Julio Gutierrez Building Permit, with the stipulation that when he finds a trailer to purchase the Council and Husky Homeowners Building Committee must approve it.

Julio asked the council if there would be anyway that he could pay some money down on the lot next to him to save it so he can purchase at a later date.

Doug made a motion, seconded by Ken Cook that by putting twenty percent (20%) down a lot for a current Husky Addition Land Owner can be saved for one (1) year, all were in favor.

Ken Cook reported that the Husky Homeowner's Association is going to be having their annual meeting on August 4th, and some Homeowners' have expressed concerns about whether they need the association, that it would be better to just let the town run everything.

There was nothing new to report in Roads & Ditches, Parks and Water & Sewer.

Bruce reported that Tom Davidson is having problems with people dumping stuff in his dumpster, the council is going to send a letter out to see if that will help with the problem.

Doug made a motion, seconded by Larry that the council will fix the alley behind Ken Cook starting in October, John Davidson and Bruce will do the work and Melissa will send letters out to the property owners so they are aware of it. All were in favor.

Doug made a motion, seconded by Wade, to pass Ordinance 09-2 Failure to Pay Charges on the first reading, all were in favor.

There being no further business, the meeting adjourned at 9:10 p.m. Wade made a motion to adjourn, seconded by Doug, all in favor. Next meeting will be August 11, 2009, at 7:30 p.m., at the Town Hall.
